

SIoux RAPIDS CITY COUNCIL SPECIAL MEETING –

April 28, 2025

The special meeting of the Sioux Rapids City Council was called to order by Jim Wise on Monday, April 28, 2025, at 5:15 p.m. at Sioux Rapids City Hall. Roll call: Jim Wise, Mike Gunderson, Mike Katschman, Todd Reiling and Joel McCoy. Amanda Caraway was also in attendance. Lacy Garberding was absent from the meeting.

Katschman moved to approve the agenda, and it was seconded by McCoy. Ayes: all, Nays: none. Absent: Garberding. Motion carried.

Katschman moved to set the Public Hearing for the Tax Levy for the Fiscal Year 2025/2026 for May 12th at 6:15 p.m. at Sioux Rapids City Hall, it was seconded by Reiling. Ayes: all, Nays: none. Absent: Garberding. Motion carried.

McCoy moved to open to the Public Hearing for the Budget Amendment for Fiscal Year 2024/2025; it was seconded by Katschman. Ayes: all, Nays: none. Absent: Garberding.

The floor was open for discussion of why the budget needed amended, and at 5:17 p.m. Katschman moved that Public Hearing for the Budget Amendment for the Fiscal Year 2024/2025 be adjourned, it was seconded by Reiling. Ayes: all, Nays: none. Absent: Garberding. Motion carried.

Katschman moved to approve Resolution No. 905 – Approval of Budget Amendment for Fiscal Year 2024/2025, it was seconded by McCoy. Roll being called, Ayes: Katschman, Gunderson, Reiling, and McCoy. Nays: none. Absent: Garberding. Motion carried.

Reiling moved to approve the purchase to of the first portion of the playground, being we have not heard back from the grant yet, they want to have it up before Tall Corn Days, and just in case we don't get the grant, this portion of the playground is already paid for with fundraising money, it was seconded by McCoy. Katschman moved to approve the purchase of pool pump parts for \$1,900.00 or so to get the pool up and running for the summer for the pump that broke last summer, it was seconded by Gunderson. Ayes: all, Nays: none. Absent: Garberding. Motion carried.

Reiling moved to accept the bid from Daniel Robinson to the job for the FEMA Buy Out Project for the lot at 314 1st, it was seconded by Gunderson. Ayes: all, Nays: none. Absent: Garberding. Motion carried.

McCoy moved to make payment to Hawk-I Plumbing in the amount of \$13,804.44 for partial installation of the HVAC system in the City Hall on the east side of the building, it was seconded by Gunderson. Ayes: all, Nays: none. Absent: Garberding. Motion carried.

McCoy made a motion to approve payment to Hawk-I Plumbing in the amount of \$17,211.21 for partial installation of the HVAC system in the City Hall building on the west side, it was seconded by Katschman. Ayes: all, Nays: none. Absent: Garberding. Motion carried.

Reiling moved to approve payment to Winwater in the amount of \$1,337.69 for a sewer pump for the lagoon, it was seconded by Katschman. Ayes: all, Nays: none. Absent: Garberding. Motion carried.

Katschman moved to approve payment to Menards in the amount of \$1,194.05 for lumber for City Hall windows and cleaning supplies, it was seconded by McCoy. Ayes: all, Nays: none. Absent: Garberding. Motion carried.

McCoy moved to approve payment to Medard's in the amount of \$1,399.80 for grass seed to replant the park from the flood, it was seconded by Gunderson. Ayes: all, Nays: none. Absent: Garberding. Motion carried.

Reiling moved to approve payment to Bomgar's in the amount of \$1,224.96 for power tools replaced from the flood, it was seconded by Katschman. Ayes: all, Nays: none. Absent: Garberding. Motion carried.

Gunderson moved to approve payment to Bomgar's in the amount of \$1,345.50 for grass seed to replant the park after the flood, it was seconded by McCoy. Ayes: all, Nays: none. Absent: Garberding. Motion carried.

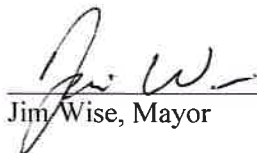
