There were no suggestions from residents.

The Library Board came and requested permission to close 2nd Street on October 21st between 2:00 p.m. and 9:00p.m. for the Sioux Rapids Library's 100th Celebration that is being planned. The City Council agreed that this plan. The Board also requested an increase in wages for the Library Director- Bethany Peat since she has completed her certification, the Board was requesting a .50 raise. Reiling moved to approve the .50 raise for Bethany Peat, and it was seconded by Swanson. Ayes: all; Nays: none. Absent: McCoy. Motion carried.

Fall Clean-Up Day is Thursday, October 12th.

Katschman moved to approve 1st reading Ordinance 472 – Street Sign -No Parking HWY 71, it was seconded by Reiling. The role being called Ayes: Gunderson, Katschman, Reiling and Swanson. Nays: none. Absent: McCoy. Motion carried.

The City Council talked about places to public semi-truck parking, but no decisions have been made yet, there is more research that needs to be done, they are going to talk to the city attorney and county supervisor and see if they have any advice first.

Katschman moved to remove Karen Currier as a Signature Authority at the Community State Bank for the City of Sioux Rapids and replace her with Holler Miller effective September 29. 2023, it was seconded by Swanson. Ayes: all; Nays: none. Absent: McCoy. Motion carried.

Swanson moved to approve the Iowa Retail Permit Application for Cigarette/Tobacco/Nicotine/Vapor for Dollar General, effective 10/01/2023, it was seconded by Gunderson. Ayes: all; Nays: none. Absent: McCoy. Motion carried.

The City Council discussed some changes to the City Code as the City Code is going through the Codification process. Which included increasing the late payment penalty from \$5.00 to 10% of the bill for payment after the 3rd of the month. Also increasing the fee for Insufficient checks received into city hall, from \$15.00 to \$30.00. Gunderson moved to approve these changes and it was seconded by Katschman. Ayes: 3, Nays: 1 Motion: Carried.




