Garberding moved to approve Resolution No. 881-Budget Amendment for Fiscal Year 2023/2024; it was seconded by Reiling. Roll being called Ayes: Garberding, Gunderson and Reiling. Absent: Katschman and McCoy. Motion carried.

Gunderson moved to approve Proposed Budget and City Taxes for Fiscal Year 2024/2025 it was seconded by Garberding. Ayes: all; Nays: none. Absent Katschman and McCoy. Motion carried.


