

**ORDINANCE NO. 476**

**AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY OF SIOUX RAPIDS, IOWA, BY AMENDING PROVISIONS PERTAINING TO WATER SERVICE CHARGES BY RAISING WATER RATES**

**BE IT ENACTED** by the City Council of the City of Sioux Rapids, Iowa:

**SECTION 1. SECTIONS MODIFIED.** Sections 92.02 and 92.03 of the Code of Ordinances of the City of Sioux Rapids, Iowa, are repealed. The following is adopted in lieu thereof:

**92.02 RATES FOR SERVICE.** Water service shall be furnished at the following monthly rates within the City:

*(Code of Iowa, Sec. 384.84)*

Gallons Used Per Month	Rate
First 2,000	\$16.57 (minimum bill)
All over 2,000	\$8.50 per 1,000 gallons

**A) SURCHARGE.** In addition, each customer shall pay a surcharge of \$22.25 per month.

**92.03 RATES OUTSIDE THE SIDE.** Water service shall be provided to any customer located outside the corporate limits of the City which the City has agreed to provide at the following monthly rates:

Gallons Used Per Month	Rate
First 2,000	\$18.32 (minimum bill)
All over 2,000	\$8.97 per 1,000 gallons

**A) SURCHARGE.** In addition, each customer shall pay a surcharge of \$22.25 per month.


**B) SERVICE CONTRACT.** No such customer, however, will be served unless the customer shall have signed a service contract agreeing to be bound by the ordinances, rules, and regulations applying to water service established by the Council.

*(Code of Iowa, Sec. 364.4 & 384.84)*

**SECTION 2. SEVERABILITY CLAUSE.** If any section, provision, or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision, or part thereof not adjudged invalid or unconstitutional.

**SECTION 3. WHEN EFFECTIVE.** This ordinance shall be in effect from and after its final passage, approval, and publication as provided by law.


